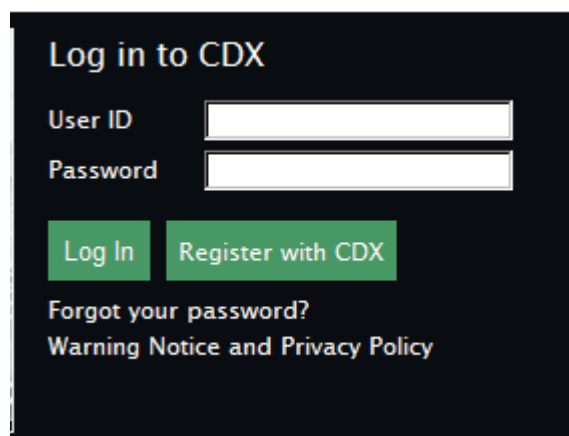
This document provides the instructions for logging-in and accessing the EMTS web application from the MyCDX portal.

1. Open CDX Web Page

- a. Open your internet browser, either IE 7.0 and higher or Firefox 2.0 and higher (no other browsers are supported) and enter the following URL:
http://cdx.epa.gov/epa_home.asp.

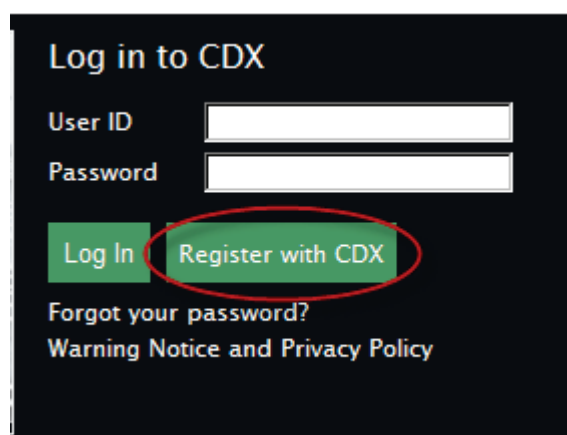
2. Login or Create MyCDX user name and password

- a. Login if you have a CDX User Name and password.

- v. EPA will need to activate your EMTS account access. In order to ensure that your account is properly activated, make sure that the appropriate delegation letter is included with your OTAQReg: Fuels Programs Registration application paperwork signed by the registered Responsible Corporate Officer (RCO).
