

# Partner Logo Qualification Truck & Multimodal Carriers

### Truck & Multimodal Carrier Partner Logo Eligibility Criteria

The SmartWay Partner logo is awarded at the partner or company level. All partner fleets contribute to the partner's performance based on their mileage weighted efficiency.

EPA awards the SmartWay Partner logo to truck and multimodal carrier partners that:

- · Submit their SmartWay Partner Tool on time
- Rank in the top half of CO2 efficiency, based on grams per mile if their average payload is 12 tons or under, or on grams per ton-mile if their average payload is above 12 tons
- · Meet the applicable 2007 or newer and 2010 or newer engine requirements
- · Sign an EPA SmartWay logo use agreement
- · Have not been found in violation of the SmartWay logo use agreement within the past three years
