Designation of Funding as an Emergency Requirement

The Congress designated as an emergency requirement the amount appropriated by division I of the FAA Reauthorization Act of 2018 (H.R. 302; the "Act"). Division I of the Act provides that the availability of the amount that is designated by the Congress as an emergency requirement pursuant to section 251(b)(2)(A) of the Balanced Budget and Emergency Deficit Control Act of 1985 (BBEDCA) is contingent upon the President subsequently so designating such amount and transmitting such designations to the Congress.

The Act provides a total of \$1.68 billion in emergency funding for the Community Development Fund at the Department of Housing and Urban Development to support the long-term recovery and revitalization of areas most impacted by disasters in 2018.

I recommend that you designate as emergency requirements the amount (including the transfer of funds) so designated by the Congress in division I the Act pursuant to section 251(b)(2)(A) of BBEDCA. Upon transmittal of this designation to the Congress, this amount will be immediately available for obligation and expenditure, unless otherwise restricted in the Act. No further congressional action will be required.

The designation of this amount as an emergency requirement allows for adjustments to the discretionary spending limits as specified in section 251(b)(2)(A) of BBEDCA. These adjustments will be reflected when the Office of Management and Budget submits its final sequestration report in accordance with section 254(f) of BBEDCA.

I have reviewed this proposed action and am satisfied it is necessary at this time. Therefore, I recommend that you make the requested funds available by signing the enclosed letters to the Speaker of the House of Representatives and the President of the Senate.
