Subject: *Impoundment Control Act of 1974—Release of Withheld Amounts Due to
Withdrawal of Rescission Proposals*

On January 14, 2021, pursuant to the Congressional Budget and Impoundment Control Act of 1974 (ICA),¹ then-President Trump transmitted to Congress a special message proposing rescissions from 73 appropriation accounts.² Where the President properly transmits a special message, an agency may withhold corresponding amounts from obligation for up to 45 calendar days of continuous congressional session.³ See ICA § 1012(b), 2 U.S.C. § 683(b). If Congress does not, within the 45-day period, complete action on a bill rescinding the budget authority, then the budget authority proposed to be rescinded must be made available for obligation. ICA § 1012(b), 2 U.S.C. § 683(b). The Office of Management and Budget (OMB) apportioned funds included in the January 14, 2021, special message as withheld pending rescission.⁴

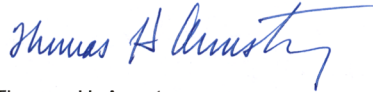
³ For the purposes of the ICA, continuity of a session of Congress is broken “only by an adjournment of the Congress *sine die*, and the days on which either House is not in session because of an adjournment of more than 3 days to a day certain.” ICA § 1011(5); 2 U.S.C. § 682(5).

On January 31, 2021, President Biden submitted a supplementary special message withdrawing the 73 rescission proposals.⁵ See ICA § 1014(c), 2 U.S.C. § 685(c). We have contacted the agencies whose budget authority was affected by the proposed rescissions and have confirmed that they have made the budget authority available for obligation, as required by section 1012(b) of the ICA.⁶ 2 U.S.C. § 683(b).
