NOTE BY THE DEPARTMENT OF STATE

Pursuant to Public Law 89—497, approved July 8, 1966
(80 Stat. 271; 1 U.S.C. 113)—

“ . . .the Treaties and Other International Acts Series issued under the authority of the Secretary of State shall be competent evidence . . . of the treaties, international agreements other than treaties, and proclamations by the President of such treaties and international agreements other than treaties, as the case may be, therein contained, in all the courts of law and equity and of maritime jurisdiction, and in all the tribunals and public offices of the United States, and of the several States, without any further proof or authentication thereof.”

At the request of the Embassy of the United States of America in Madrid, the Consulate General in Barcelona presents its compliments to the Ministry of Foreign Affairs of the Principality of Andorra and has the honor to refer to the Memorandum of Understanding between the Government of the United States of America and the Government of the Principality of Andorra on the Fulbright Exchange Program signed at Ordino on February 2, 2015 (hereinafter referred to as the “MOU”).

The Embassy, on behalf of the Government of the United States of America, proposes that, pursuant to Article 6 of the MOU, the MOU be extended with effect from December 31, 2020, for an additional five-year period, through December 31, 2025.

If the foregoing proposal is acceptable to the Ministry, the Embassy proposes that this note, and the Ministry’s note in reply to that effect, shall constitute an Agreement between the two governments to extend the MOU for a five-year period with effect from December 31, 2020, which shall enter into force on the date of the Ministry’s note in reply.
