SIR: I have the honor to submit herewith for your consideration, and upon your approval for transmission to Congress, a supplemental estimate of appropriation for the fiscal year ending June 30, 1926, for the War Department, amounting to \$9,403.42.

Relief of McLennan County, Tex. \$9,403.42

The act approved June 9, 1926 (Public, No. 362, 69th Cong.), authorizes an appropriation of \$9,403.42 and authorizes and directs

the Secretary of the Treasury to pay the same to McLennan County, Tex., or to the proper fiscal officers of such county, to compensate the said county for the value of an improved public highway located therein which passed through a military camp at Waco, Tex., and which was appropriated by the United States Government during the World War, closed to public use, and destroyed in order to make said military camp available as an aviation field. The purpose of this estimate is to carry out the provisions of said act.

This estimate of appropriation is required to provide for legislation which has been enacted since the transmission of the Budget for the fiscal year 1926, and its approval is recommended.
