REPORT

[To accompany H. R. 10424]

The Committee on War Claims, to whom was referred the bill (H. R. 10424) entitled "A bill to ratify the action of a local board of sales control in respect of a contract between the United States and Max Hagedorn, of La Grange, Ga.," having considered the same, report thereon with a recommendation that it do pass without amendment.

STATEMENT OF FACTS

On November 15, 1921, the claimant purchased 10,000 pairs of marching shoes under sales contract S. E.-4462 from the United States Government. These shoes were stored in the Candler warehouse in Atlanta, Ga., and owing to the fact that they were carefully stored in boxes and bundles, the bids were submitted based on samples shown by the Government representatives. The claimant bought the shoes at a price of \$1.59 per pair. After examining the goods he found them very inferior to the samples shown. The local board of sales control of the War Department took the sale under consideration and reduced the price to \$1 per pair.

The proposed legislation is merely to ratify the action of the local board of sales control in reducing the price of these shoes and has the recommendation of the War Department as is evidenced by a letter from the Secretary of War under date of April 2, 1926, which is

appended hereto and made a part of this report.
