SIR: I have the honor to transmit herewith for the consideration of Congress a supplemental estimate of appropriation to provide home care for dependent children in the District of Columbia for the fiscal year ending June 30, 1927, as authorized by the act of June 22, 1926 (Public, No. 410, 69th Cong.), amounting to \$75,000.

The details of the estimate, the necessity therefor, and the reason for its submission at this time are set forth in the letter of the Director of the Bureau of the Budget transmitted herewith, with whose comments and observations thereon I concur.

SIR: I have the honor to submit herewith for your consideration, and upon your approval for transmission to Congress, a supplemental estimate of appropriation to provide home care for dependent children in the District of Columbia for the fiscal year ending June 30, 1927, amounting to \$75,000, as follows:

Home care for dependent children, District of Columbia \$75,000

The purpose of this estimate is to carry out the provisions of the act of June 22, 1926 (Public, No. 410, 69th Cong.). While this act authorizes an appropriation of \$100,000 for the fiscal year ending June 30, 1927, the necessary delays in the organization of the work will not permit full operation from the beginning of the fiscal year; and it is believed that the amount of the estimate herewith, \$75,000, will be sufficient for the first year's operation under the new law

The foregoing estimate of appropriation is required to carry into effect legislation enacted since the transmission of the Budget for

the fiscal year 1927. Its approval is recommended.
