PROPOSED LEGISLATION AFFECTING AN EXISTING APPROPRIATION

PROPOSED LEGISLATION AMENDING EXISTING LAW

The limitation on expenditures by the Clerk of the House of Representatives for supplies or utensils used in the barber shops of the House Office Building or the House side of the Capitol, made by the act of July 16, 1914 (38 Stat. p. 462), shall not hereafter apply to the purchase of necessary furniture.

DEAR SIR: I submit the following deficiency and supplemental estimates of appropriations for the service of the House of Representatives, to wit:

Salaries of Members and Delegates, House of Representatives 1925 and 1926_______\$1,470,833.33

The deficiency act of March 4, 1925 (vol. 43, p. 1313), made immediately available the appropriation of \$3,304,500, for compensation of Members of the House of Representatives, Delegates from the Territories, the Resident Commissioner from Porto Rico, and the Resident Commissioners from the Philippine Islands, for the fiscal year ending June 30, 1926, the legislative act of March 4, 1925 (vol. 43, p. 1301), having fixed their compensation at \$10,000 per annum and that of the Speaker of the House at \$15,000 per annum.

These rates of compensation, therefore, became effective March 4, 1925, in lieu of the former rates of \$7,500 and \$12,000, respectively and the additional compensation was paid and is being paid from the appropriation for the fiscal year 1926, as authorized by the deficiency act of March 4, 1925, resulting in a deficiency as follows:

SUPPLEMENTAL ESTIMATE

Office of the clerk: For compensation of three additional telephone operators, at \$100 per month each, from Jan. 1, 1926, to June 30, 1927_______\$5, 400. 00

This is made necessary by the installation of a new switchboard in the House Office Building with 19 positions, 5 more than were carried on the old board, in order efficiently to handle the increased business.

DEFICIENCY ESTIMATE

For pay of substitute telephone operator, fiscal year 1926_____ \$623.70

The current appropriation of \$500 for substitute telephone operator is on the old basis of pay, \$2.50 per diem, and is inadequate. The per diem rate is now \$3.30. The three-year average is 26 working days a month, or \$1,029.60 per year. On this basis the amount of the estimate will be necessary for this service from December 24, 1925, to June 30, 1926, 189 working days.

Contingent expenses, House of Representatives: Miscellaneous items, 1925_______\$20, 848. 35

This amount represents unpaid vouchers for telegraph and telephone service, as follows:

For telegrams \$11, 103. 34
For telephone service, all charges except operation 9, 745. 01

Total_________20, 848. 35

It is recommended that an unexpended balance, fiscal year 1924, of \$8,000 be reappropriated and made available for this purpose, thereby reducing the amount of the deficiency to \$12,848.35.

This unexpended balance accrued by reason of the payment from the appropriation for the fiscal year 1925 of amounts approximating the total amount of this deficiency to beneficiaries of deceased employees of the House of Representatives under authority of resolutions of the House, instead of from the appropriation, fiscal year 1924.

It is also recommended that the following limitation in the act of July 16, 1914 (Stat. L., vol. 38, p. 462), be amended by striking out the word "furniture," viz:

Hereafter it shall be unlawful for the Clerk of the House to pay out of any moneys of the House of Representatives any bills for laundry, furniture, supplies, or utensils used in the barber shops of the House Office Building or the House side of the Capitol.

The furniture in these shops is the property of the United States. It is very old and in need of replacement. Some of the chairs are in unsafe condition. Neither repairs nor new equipment can lawfully be furnished while the inhibition as to furniture remains, and it is thought unreasonable to impose this expense upon the employees whose occupation is practically limited to the duration of the sessions of Congress.
