SIR: I have the honor to transmit herewith for the consideration of Congress a supplemental estimate of appropriation for the Department of State for the fiscal year ending June 30, 1927, amounting to \$75,000.

The details of this estimate, the necessity therefor, and the reason for its submission at this time are set forth in the letter of the Director of the Bureau of the Budget transmitted herewith, with whose comments and observations thereon I concur.

In pursuance of authority contained in Public Resolution No. 5, approved February 1, 1926, Congress granted an appropriation of

\$50,000 in the first deficiency act, fiscal year 1926, approved March 3, 1926, for the expenses of participation by the United States in the work of the preparatory commission that met at Geneva, Switzerland, May 18, 1925, which appropriation is now exhausted. The work of this commission has been continued through plenary sessions and subcommittee meetings since that date. The task of the commission's subcommittee, to which was delegated the detailed study of many of the problems presented to it, has virtually been completed, and it is planned to hold another plenary meeting of the commission probably in March, 1927, to consider the subcommittee reports. The delegation will probably be composed of 4 delegates, 9 assistants, and 7 clerks, and the estimate of \$75,000 is computed on the basis of a session lasting six months.

This estimate of appropriation is required to meet an unforeseen contingency which has arisen since the transmission of the Budget for the fiscal year 1927 and its approval is recommended.
