SIR: I have the honor to transmit herewith for the consideration of Congress a supplemental estimate of appropriation for the Department of State for the fiscal year ending June 30, 1927, amounting to \$15,000.

SIR: I have the honor to submit herewith for your consideration a supplemental estimate of appropriation for the Department of State for the fiscal year ending June 30, 1927, amounting to \$15,000.

The Government of the United States has been invited by the Council of the League of Nations to take part in the appointment of members of the economic conference which will meet at Geneva, Switzerland, on May 4, 1927. The conference is not to be composed of responsible delegates invested with full powers for the conclusion of conventions, but it is intended rather to organize a general consultation in the course of which the various programs and doctrines may be freely exposed without the freedom of discussion being restricted by any immediate necessity to transform the conclusions of the conference into international engagements.

The invitation specified that each country is to appoint not more than five members. The members may be accompanied by experts who may attend the meetings, but without the right to speak or vote except with the special permission of the conference.

This estimate of appropriation is required to meet an unforeseen contingency which has arisen since the transmission of the Budget for the fiscal year 1927 and its approval is recommended.
