REPORT

The Committee on Interstate and Foreign Commerce, to whom was referred the bill (H. R. 11978) a bill granting the consent of Congress to the commissioners of McKean County, Pa., to construct a bridge across the Allegheny River, having considered the same, report thereon with amendment and as so amended recommend that it pass.

The bill as amended has the approval of the War and Agriculture Departments, as will appear by the letters attached and which are made a part of this report.

Amend the bill as follows:

Line 7, page 1, strike out the last two words in the line:

Line 8, page 1, strike out the line; Line 9, page 1, strike out "211 crosses said river;"

R. 11978, Sixty-eighth Congress, second session, "Granting the consent of Congress to the commissioners of McKean County, Pa., to construct a bridge across the Allegheny River," if amended as indicated in red thereon. As the navigable portions of the Allegheny River do not lie within the limits of a single State the consent of Congress is required under section 9 of the river and harbor act of March 3, 1899 (30 Stat., 1151), for the construction of a bridge

thereover.

DEAR MR. WINSLOW: I have your letter of January 29, inclosing a copy of H. R. 11978, with request for a report thereon and such views as the department may desire to communicate.

This bill proposes to grant to the Commissioners of McKean County, Pa., authority to construct, maintain, and operate a bridge and approaches thereto across the Allegheny River where Pennsylvania State Highway No. 211 crosses said river about 1 mile south of Larabee. This route forms a part of the Federal aid highway system and we understand from the State Highway Department of Pennsylvania that the bridge will be free from tolls when constructed.
